

BOARD OF DIRECTORS REPORT

orty representatives from 18 CCRCs (4
Western, 3 Central and 11 Eastern) met
on a beautiful spring day at Carolina Meadows
May 8. There were the usual reports from the

Executive Committee. The Treasurer's report showed, relative to our budget, we are in good shape. Sandy Wigdor, as outgoing chair of the Eastern Region, presented a "Road Map" of what Eastern Region officers did in 2018-2019. This "Road Map" can be a guide for all regions as new officers assume their responsibil-ities; they don't



Art Cooper presented a new document drafted by the Executive Committee on *Duties of a NorCCRA Community Representative*, which gives guidance especially to those newly taking on the responsibility within their CCRC.

Sindy Barker gave a legislative update, and the good news is that things are quiet - - "no red

flags being raised." Several NorCCRA members wrote their Congressmen and Senators asking support for maintaining the 7.5% medical expense deduction. No responses have been

received, so hopefully no news is good news. Regarding hospital observation vs. admission, this session of U.S. Congress H1682/S753 Improving Access to Medicare Coverage of 2019 attempts to amend Title XVIII (Medicare) of the Social Security Act. With respect to posthospital extended care services, any period of Observation shall count as In-patient days, and if discharged after three midnights,

patients are eligible to be considered for extended care in a skilled nursing facility. At this time David Price is the only North Carolina Congressman to sign on as a co-sponsor; neither NC Senators have done so. Sindy is asking residents to get in touch with both Senators and their Representatives asking them to co-sponsor HR 1682 or S753. The most effective way will be to contact them through their website. Nancy Wise has replaced Steven Johnson as Manager of the Special Entities at DOI. (See pages 4 and 6.)

Sindy Barker's tenure as Board Member for NC Leading Age is over, and NorCCRA will now be represented by Wayne Campbell.

And so from my home to yours, may good health and much happiness be yours as we have moved past winter and most of a wonderful spring!





Encountering the "Other"...Or the Stranger in our Midst

n early 2017, as the national cultural scene began reflecting animosity toward a variety of groups, several residents and the heads of Croasdaile Village's Life Enrichment and Chaplaincy Services departments met to discuss holding a program at Croasdaile Village which came to be titled "Encountering the 'Other' or The Stranger in Our Midst."

Over eight weeks during the months of January and February, 2018, Croasdaile Village held a weekly afternoon film program for residents who were invited to consider the "other"—those not like ourselves. Topics explored included those of a different race, religion and social class, as well as recent immigrants, LGBT, and those facing mental or physical challenges. (Examples: *Guess Who's Coming to Dinner, Billy Elliott*, and *The Birdcage*.)

Each session was introduced with a brief skit by two "cousins" — Ima Wright (Denise Waters, Director of Life Enrichment and Associate Chaplain), supposedly from Alabama and a new resident at Croasdaile Village, and her cousin, Nevah Rong (Rev. Laurie Hays Coffman, our Chaplain) who had come from Texas to help her cousin settle in. Their conversations were a humorous commentary on a variety of "others," including a side-splitting reveal when Nevah finally told Ima that their niece had become engaged to, of all things a real "other", a Yankee! The day's film was then briefly introduced and screened. Following each film residents were invited to discuss their own feelings about that day's topic and their own contacts with others.



On a different day each week a separate class was conducted by Rev. Hays Coffman, with a reading and discussion of the book *Fear of the Other: No Fear in Love* by Bishop William H. Willimon, who is currently a Professor at Duke Divinity School and a former Dean of the Chapel at Duke University. In addition our Library put together a collection of books and DVDs on the topic for residents.

Those who participated in either or both sessions shared many very personal stories. We are exploring some ways to continue the dialog!

Sustainability MONTH AT CAROLINA MEADOWS

Carolina Meadows held its first "Sustainability

Month" in February 2019 with programs every Friday afternoon where four groups of sustainability professionals exchanged their views. The main purpose was to learn from sustainability professionals in the neighboring counties of Chatham and Orange, and from several local universities and colleges, and to learn about the United Nations Sustainable Development Goals and their local connections and finally, exchange views with neighboring CCRCs.

Kevin Lindley, Environmental Quality Director for Chatham County spoke on his successful use of "collaborative impact teams." These are departments that are grouped together because they serve similar functions. The power of the teams is that they establish an institutional collaboration that might not otherwise occur, with the comprehensive plan as the centerpiece.

The second speaker from Chatham County was Shannon Culpepper, Solid Waste and Recycling Division Waste Reduction Coordinator. The third speaker was Brennan Bouma, Orange County's first Sustainability Coordinator. Bouma's advice for Carolina Meadows as they embark on sustainability efforts was: i) sustainability takes champions and has to be an ongoing effort, not just a one time project; ii) get a quick iii) don't forget social recognizable success; equity: you may need to prioritize who gets benefits first; iv) as you make progress you will need the input and support of those outside your immediate area.

The fourth speaker was John Richardson, Planning Manager for Sustainability in Chapel Hill. He suggests that a sustainable community is future friendly; it is a place that works to enlarge today's opportunities for tomorrow's generation. He left Carolina Meadows Sustainability Committee with six questions: 1) What resources do you have to make change? 2) What are your top goals? And why? 3) What do you have control over? 4) Who are your influencers? 5) What can you measure? 6) What is an easy win?

J. Robert Cox from Galloway Ridge and Lew Woodham from Carol Woods spoke to the group about sustainability activities at their respective CCRCs. And from the local universities, Kelly Harer from Elon University; Adam Long, UNC; and Andrew McMahan, Central Carolina Community College. STARS, The Sustainability Tracking, Assessment & Rating System (https://stars.aashe.org) a transparent, self-reporting framework for colleges and universities to measure their sustainability performance was discussed.

It was concluded that working collaboratively with diverse outside sustainability professionals is rewarding both for CCRC residents and also for those outside persons and organizations. Thus the idea has been discussed to start a Central Carolina sustainability working group. On a quarterly basis residents of neighboring CCRCs would come together to discuss sustainability initiatives with invited guests. Dear Nancy,

Congratulations and we are delighted with your selection as Manager of Special Entities. We so admired the skill that Steve Johnson brought to both the application review process and the care he took in making sure that each CCRC continued to be financially solvent. I know he was hopeful that you would move into the Special Entities section.

Over the years, the North Carolina Continuing Care Residents Association (NorCCRA) has worked closely with both the Department of Insurance and LeadingAge NC to address issues that are of concern to both the CCRC residents and management.

In preparation for the possibility that the Department of Insurance planned to introduce technical amendments to Chapter 58, Section 64 Continuing Care Retirement Communities CCRCs in 2019, the NorCCRA Legislative Committee put together a workgroup to review Section 64 and identify sections that we believe to be essential to the financial stability of CCRCs. Our plans are to work closely with the LeadingAge NC Public Policy Committee with the hope of coming to an agreement on any proposed amendments to the statute in 2021. Recently, the Florida residents association and Florida LeadingAge were able to reach an agreement before coming before their legislature.

We would look forward to an opportunity to sit down with you so you could get a feel for NorCCRA and CCRC residents and how all of us can be of assistance to our residents.

Twin Lakes Semi-Annual Estate Sale

Twin Lakes Auxiliary conducted its semiannual Estate Sale March 14 to the 16th. Over 130 Twin Lakes Community residents volunteered their time during the sale, but many of those same volunteers spent countless hours cleaning out vacated residences, storing and pricing goods, and setting up for the sale.

Proceeds from the sale totaled over \$21,000 and are used to fund college scholarships for children of Twin Lakes employees. Currently, Twin Lakes gives 28 young people a scholarship of \$1700 every year so they can attend college. For many, this scholarship is



the difference between attending or not attending college.



The sale i s conducted in the fall and in the spring. Case goods, clothing, kitchen and dining goods as well as outdoor furniture and tools are for sale at the twice yearly sale. In addition, the fall sale includes a Christmas room that stocks and sells

holiday decorations. During the spring sale, a book sale is held.

Twin Lakes retail store, staffed by resident volunteers, also participates with high end jewelry, decorations, and gift ware all donated by residents who are moving, cleaning house, or who have passed away.

Twin Lakes administration paid overtime wages for staff to move furniture and load onto trucks for customers all the days of the sale.



MEMBERSHIP UPDATE

Since the President's Report in the March Hotline, significant progress has been made in NorCCRA membership. As of April 11, NorCCRA has 4143 members. By region, Western has 917, Central 756 and Eastern 2215. Super Kudos go to Croasdaile Village, Cypress Glen and Aldersgate whose communities have achieved NorCCRA memberships with 65% or more of their residents. And, Kudos go to Scotia Village, The Forest at Duke and Glenaire who have NorCCRA memberships representing 50% or more of their residents (see chart.) We still have 24 CCRCs in North Carolina with no NorCCRA members, so if you have friends living in one of those communities, introduce them to the benefits of NorCCRA. membership.
