Trinity Oaks Retirement Community will host The NorCCRA Annual Membership Meeting On Tuesday, October 10, 2023. This is our first in person annual membership meeting since October 2019. Our speakers will address the various Medicare programs and provide insight and perspective on the future of medical care for seniors.



Gina Upchurch is the founder and Executive Director of Senior PharmAssist, a nonprofit organization that assists older adults with obtaining and managing medication and provides Medicare benefits counseling and tailored community referrals in Durham, NC. She is a registered pharmacist and has participated in various committees at the state and federal level, such as the American Geriatrics Society Public Policy Committee and several working groups to the NC Institute of Medicine. Gina received her bachelor's and master's degrees in Pharmacy and Public Health from University of North Carolina at Chapel Hill. She has just been appointed by the Comptroller General of the US to the Medicare Payment Advisory Committee (MedPAC).



Dr. Jonathan Kotch, a board-certified medical specialist in pediatrics and preventive medicine, retired in 2016 after 38 years on the faculty of the Department of Maternal and Child Health of the UNC Gillings School of Global Public Health. His research expertise focused on health and safety in out-of-home child care and longitudinal studies of child abuse and neglect. His advocacy activities include 14 years as president of Health Care for All NC, a chapter of Physicians for a National Health Program, and North Carolinians against Gun Violence. As a 5 year resident of Carolina Meadows, he served as the chair of the Residents' Health and Wellness Committee during the height of the COVID-19 epidemic, and currently is chair of the Residents' Environmental Sustainability Committee which he helped found in January, 2023. He will speak to us about his perspective on current and future medical care for seniors in US.

President's Message from Skip

We especially looked forward to that week or two called vacation. Sometimes, the whole family packed up and went on a trip to the seashore, the mountains, or foreign countries like Florida and Oklahoma.

But we all knew that summer would end, and school would once again demand our full attention. During the first week of school there was always that dreaded assignment, write an essay on "What I Did this Summer!" Some years were easy. I wrote about the 29-inch Muskie I caught in Canada or the summer I learned to waterski in Deep Creek, Maryland or the summer my idol, Smokey Burgess, the catcher for the Pittsburgh Pirates gave me his catcher's mitt. Then there were the summers filled with baseball, swimming, etc., fun, but not memorable enough to write. Which brings me to "How did I Spend the Summer of 2023:.

This essay has neither a good nor a bad ending. As of today, it is unfinished. What I did this summer was to attend numerous meetings with the Department of Insurance, NC Senators and Representatives and their staffs, attended four Senate committee meetings, and the Senate session where the proposed CCRC Statute S145 was passed. While the legislative agenda has consumed a lot of time for Sindy, Martha and me, others have been working on important projects. Margaret Zircher has been putting together a couple of Google docs to help us maintain our lists of directors and CCRC residence council presidents and working on an electronic file to house NorCCRA archives. Sharon Everhart has been diligently working to provide knowledgeable and relevant speakers to the Annual Membership meeting in October.

The Nominating Committee (John Olmstead, Bob Osborn, David Teal and Art Cooper) have completed their work and presented me with their nominees as required by our by-laws. The Nominees and are listed on 6.

Bill Lambe has undertaken the task of revising the NorCCRA "Standing Rules" and "By-laws" to bring them into conformity with current rules and operations. The Standing Rules were approved at the June Board of Directors meeting and are now posted on the NorCCRA website. The changes to the By-laws are as follows;

Unfortunately, we have no updates since the June report. The General Assembly essentially took a six-week break beginning the first of July. As of now, we expect the legislature to reconvene on August 15.

At a press conference in early August, House Speaker Tim Moore forecasted a "zero" chance that a final budget



would become law before September 1. "Just with some absences I know that the Senate has on their side, and with just some of the logistics that have been talked about ... you're talking about a September date for actual passage – signing (the bill) into law and all that." Moore said.

Initially, plans were to enact the budget by July 1, which is the beginning of the State's fiscal year. The House passed their budget in early April; the Senate passed their budget in mid-May. The House rejected the Senate's version on May 26. A conference committee was appointed in early June and has worked during the summer months trying to reach a compromise.

In addition to voting on the budget, both houses need full representation by Republicans to override the five pieces of legislation vetoed by Governor Roy Cooper. Senate Republicans have a supermajority with 30 out of 50 seats. The House gained a supermajority in March when Representative Trish Cotham switched to the Republican party. Since then, the Governor's veto has been overridden ten times. Representative Moore and Senator Berger are counting their votes to determine when a bill will be taken up for override.

What does this mean for NorCCRA's legislative initiatives?

Because of the budget impasse, legislation that passed one house is being held by the Rules Committee in the other house. This applies to **S145**, **Continuing Care Retirement Communities**. After a busy June the bill passed three Senate committees and the full Senate on June 28. It was sent by special messenger to the House and has remained in the House Rules Committee since then.

ARTICLE I - Name and Location

Change the corporate address to reflect the address listed with the North Carolina Secretary of State.

ARTICLE VIII - Executive Committee

Section 2. Powers

The change is to eliminate the second half of the paragraph, which is an exact duplicate of the first half.

Section 3. Meetings

The Executive Committee shall meet at the call of the President. Five members shall constitute a quorum. All actions shall require the approval of a majority of those members eligible to vote present and voting unless restricted by other provisions within these bylaws. The first meeting of a new Executive Committee may be via teleconferencing or in person, at the option of the President. Teleconferencing includes Zoom and other virtual media.

ARTICLE X - REGIONS

Section 3. Officers

Section 5. Finances

The changes to both Section 3 and 5 conform to the eliminations of treasurers in the Regions.

The proposed changes to the By-laws will be voted on at the October meeting.

Legislative Update, continued

We still have no word on the sales tax exemption in the budget negotiations. Since it was in the House budget, but not in the Senate version, it remains one of the items the two houses will need to reach agreement on. Other items include Medicaid expansion, teachers' salaries, casinos built outside of tribal lands, reduction in the individual income tax rate, and more.

If the Senate and House return to business on August 15, the budget conference committee may present a budget at that time. That will be the first opportunity to see if the sales tax exemption is included in the budget. It might also mean that the bills being held in Rules Committees will be assigned to committees for discussion.

We hope to know a lot more by the first of September.
